A bidder may also express its intention not to participate in the bidding through a letter which should reach and be stamped received by the BAC before the deadline for the receipt of bids. A bidder that withdraws its bid shall not be permitted to submit another bid,

### REMINDERS:

- A. Bid Security: Valid for 120 calendar days from the date of submission and opening of bids.
- **B.** Document Submission Format:
  - > Combine eligibility documents and technical proposal in one folder.
  - Place the financial proposal in a separate folder.
  - Use shoelace binding instead of a fastener.
  - > Include a table of contents and use index tabs labeled in words, not numbers.

### C. Envelope Packaging:

- > Place the eligibility requirements and technical proposal folder in one sealed envelope.
- > Place the financial proposal folder in a separate sealed envelope.
- > Enclose both envelopes in a single outer envelope labeled as "Original Bid."

# D. Document Labeling:

Each envelope should clearly indicate the following:

- > Name of the Project and Bid Reference Number in CAPITAL LETTERS
- > Name and Address of the Bidder in CAPITAL LETTERS
- > The phrase "DO NOT OPEN BEFORE: May 6, 2025 (Tuesday), 9:00 A.M.

## E. Submission Format:

- > Submit one (1) original and two (2) copies of both the Technical and Financial Proposals.
  - Label accordingly: "ORIGINAL," "COPY 1," and "COPY 2."
- F. Unchanged Provisions: All provisions in the Bidding Documents not affected by this bulletin remain in effect.
- G. Late Submission: Any bid submitted after the deadline will be declared "LATE" and will not be accepted.
- H. Bid Opening: The BAC will open the bids immediately after the deadline for submission and receipt of bids
