INVITATION TO BID

 The NATIONAL CENTER FOR MENTAL HEALTH, through the INCOME CY 2019 intends to apply the sum of PHP 1,431,166.00 being the Approved Budget for the Contract (ABC) to payments under the contract for the project below. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Prospective Bidders for **Other Supplies** should have experience in undertaking similar projects within the last two (2) years with an amount of at least 25% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Detailed Bid-Evaluation & Post-Qualification of the lowest-calculated bid shall be conducted, and;

The NATIONAL CENTER FOR MENTAL HEALTH now invites bids for Public Bidding for Other Supplies-Engineering Tools and Devices (Lot) CY 2019 and Public Re-Bidding for Supply and Delivery of Various Office Supplies and Forms CY 2019. Delivery of the Goods is required as specified in the SCHEDULE OF REQUIREMENTS. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Bid opening shall be on <u>August 27, 2019 (Tuesday) 9:00AM</u> at BAC CONFERENCE ROOM, PROCUREMENT SECTION OF NATIONAL CENTER FOR MENTAL HEALTH COMPOUND, MANDALUYONG CITY. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. <u>Late bids shall not be accepted</u>.
